### **OLD BUSINESS**

# **SR 62 Waterline Replacement**

Kyle Schwabenbauer met with township resident, Robert Delaney, about a 48"X62" sidewalk that was cracked sometime during the project. Terraworks says they didn't have equipment that close to his house. The township will fix it in the spring.

Terraworks needs to come back and seed approximately 10 properties. Punch list items are down to \$1600, but \$10,500 is still being held in retainage.

The hydrant location map was digitally sent and Kyle gave Mike a hard copy today. Mike asked Kyle to see if they are numbered, Kyle will look into that.

Kyle Schwabenbauer asked for a motion to pay EADS/Pennvest payment request # 9 for a total of \$1598.53 for EADS, the total amount \$2292.41. Project is at 73% to date. Rob made the motion to pay EADS in the amount \$1598.53, Mike Deibert second, all in favor. **Motion carried.** The second motion for the Pennvest payment request #9 for \$2292.41 was made by Mike Erwin, Gary second, all in favor. **Motion carried.**
