## 4. STAFF REPORTS

**Road Master** – Ted Williams said that his crew plowed roads 11 days spreading 102 (10) ton loads and 57 (1) ton loads of salt/antiskid, and accumulated 105 hours of overtime. They also installed 1 driveway pipe, started sweeping roads, repaired street signs, patched pot holes 4 days, graded roads 2 days, and ditched roads for 2 days.
