PUBLIC COMMENTS ON THE AGENDA.

4. STAFF REPORTS

Township Manager Sabrina S. Backer – Sabrina reported the Township will hold a scrap metal drop off on October 11th. She reminded the public that the Township is actively working on an ATV ordinance but one has not been adopted yet and PennDOT has not adopted an ordinance, at this time, ATVs are not legally allowed on roadways within the Township. Trick or Treat will be held October 31st from 6:00pm – 8:00pm. Work has begun on Aires Hill Road bridge. Once the bridge is completed STV will need to inspect the bridge before it can be opened to the public.
